Subject: Oklahoma Tornadoes Disaster Notification – Update #4

FEMA Declaration Date: May 13, 2024

On April 30, 2024, the Federal Emergency Management Agency (FEMA) declared that federal disaster aid with individual assistance has been made available to county in **Oklahoma** to supplement recovery efforts in the areas affected by severe storms, straight-line winds, tornados, and flooding from **April 25, 2024**, to **May 9, 2024**.

On May 3, 2024, with **Amendment No. 1**, the Federal Emergency Management Agency granted individual assistance to 1 additional county.

On May 7, 2024, with **Amendment No. 2**, the Federal Emergency Management Agency granted individual assistance to 1 additional county.

On May 9, 2024, with **Amendment No. 3**, the Federal Emergency Management Agency granted individual assistance to 2 additional counties.

On May 10, 2024, with **Amendment No. 4**, the Federal Emergency Management Agency announced an Incident Period End Day of May 9, 2024.

On May 13, 2024, with Amendment No. 5, the FEMA granted to 1 additional county.

On May 22, 2024, with **Amendment No. 8**, The Federal Emergency Management Agency granted individual assistance to 5 additional counties.
