Subject: Texas Tornadoes Disaster Notification – Update #5

To: All

FEMA Declaration Date: June 4, 2024

On May 17, 2024, the Federal Emergency Management Agency (FEMA) declared that federal disaster aid with individual assistance has been made available to county in **Texas** to supplement recovery efforts in the areas affected by severe storms, straight-line winds, tornadoes, and flooding from **April 26, 2024, to June 5, 2024**.

On May 21, 2024, with *Amendment No. 2*, FEMA granted Individual Assistance to 6 additional counties.

On May 22, 2024, with *Amendment No. 3*, FEMA granted Individual Assistance to 2 additional counties.

On May 27, 2024, with *Amendment No. 5*, FEMA granted Individual Assistance to 4 additional counties.

On May 29, 2024, with Amendment No. 6, FEMA granted Individual Assistance to 3 additional counties.

On June 4, 2024, with Amendment No. 7, FEMA granted Individual Assistance to 5 additional counties.

On June 7, 2024, FEMA granted Individual Assistance to 5 additional counties and displayed an Incident Period End Date of June 5, 2024, on the FEMA website.

Loans that have already been issued a Final Approval or Clear to Close status will be placed in an Approved with Condition status until a re-inspection is performed.

We will continue to monitor the situation and add or remove any additional areas as needed.
