Subject: Georgia Hurricane Helene Disaster Announcement Update #5

FEMA Declaration Date: October 1, 2024

On September 30, 2024, the Federal Emergency Management Agency (FEMA) declared that federal disaster aid with individual assistance has been made available to county in **Georgia** to supplement recovery efforts in the areas affected by Hurricane Helene from **September 24, 2024, and continuing.**

On October 1, 2024, with <u>Amendment No. 1</u> FEMA granted Individual Assistance to 30 additional counties. On October 3, 2024, with <u>Amendment No. 2</u> FEMA granted Individual Assistance to 4 additional counties. On October 4, 2024, with <u>Amendment No. 3</u>, FEMA granted Individual Assistance to 8 additional counties. On October 9, 2024, with <u>Amendment No. 4</u>, FEMA granted Individual Assistance to 4 additional counties. On October 11, 2024, with <u>Amendment No. 5</u>, FEMA granted Individual Assistance to 2 additional counties.
