FEMA Declaration Date: September 29, 2024

On September 29, 2024, the Federal Emergency Management Agency (FEMA) declared that federal disaster aid with individual assistance has been made available to county in **South Carolina** to supplement recovery efforts in the areas affected by Hurricane Helene from **September 25, 2024, and continuing.**
